# Contract Bridge Association of Ireland Lady Milne & Camrose Trials Pre-qualifying competition

The Lady Milne Trophy and the Camrose Trophy are home international competitions in which teams from England, Northern Ireland, Republic of Ireland, Scotland and Wales compete against each other annually.

The Lady Milne Trophy is for women's teams only and the Camrose Trophy is an open competition.

The dates and venues for these events in the coming season are:

Lady Milne date: 21st to 23rd April 2023 Scotland unless online

Camrose dates: Weekend 1: 6<sup>th</sup> to 8th January 2023 Northern Ireland unless Online

Weekend 2: 3<sup>rd</sup> to 5th March 2023 In Ireland unless Online

The C.B.A.I. International Committee (I.C.) will hold trials to select two 5-6 player teams to represent the Republic of Ireland in these competitions. The minimum entry requirement (unless nominated by the CBAI Junior Committee or selection via Pre-qualifying trials) is for entrants to hold 100+ National Points.

The dates for these trials are:

Camrose trials: 29-31<sup>st</sup> October 2022 Lady Milne trials: 11-13<sup>th</sup> November 2022

Prior to these trials, the I.C. is inviting players of a suitable standard, but who are otherwise unable to enter the main trials, to pre-qualify. This trials pre-qualifier will be held on **24-25**<sup>th</sup> **September** in Templeogue unless online and thereafter on the fourth Saturday and Sunday every September

### **Entries**

Entries are invited from pairs hoping to play for Ireland in either the Lady Milne or the Camrose Trophies. A player may not enter these trials if they are already entered into the Lady Milne or Camrose trials.

Entry is restricted to players with either

- 50+ National Points
- 25+ National Points won in the previous three bridge seasons

The closing date for receipt of entries is 12<sup>th</sup> August 2022 and entries, accompanied by an entry fee of €70 per person, **must** be submitted to C.B.A.I. National Headquarters on or before that date. The I.C. may, in exceptional circumstances, accept entries after the closing date.

Particulars of the pre-qualifier's format, together with any plans to go online, will be sent to entrants within a Supplementary notice in the week following the closing date.

### The event is dependent upon a minimum entry of 12 pairs

### **Format**

The Pre-qualifier will be a three-session, IMP pairs competition.

The two best placed women's pairs will be eligible to play in the Lady Milne trials. If one or both pairs placed in the top two, then they may elect to play in the Camrose trials and the next best women's pair(s) will qualify to play, as a team, in the Lady Milne trials. Once the Lady Milne qualifiers are known then the best placed two remaining pairs will qualify to play, as a team, in the Camrose trials.

If it transpires that, due to shortage of suitable entrants, only one pair is eligible to qualify for the Lady Milne trials then there will be no pre-qualifying team for that event

Players who qualify to play in the trials for either the Lady Milne or the Camrose will receive a credit equivalent to the entry fee of the Pre-qualifier which can then be put towards their entry fee for the main trial.

Whereas the exact schedule and number of boards per round will be decided after the closing date when the number of pairs entered in the trials is known, it will involve a single or double round robin, with each pair playing a direct match over as many boards as possible against each of the other pairs.

Players will be awarded National Points (see www.cbai.ie for details)

### Rules/Regulations re Substitutes and Systems for Pre-qualifiers

#### Substitutes

Subject to the approval of the International Committee (I.C.), a substitute may be allowed in emergency circumstances for a limited number of boards. A substitution, which in the opinion of the I.C. significantly affects the strength/weakness of a pair, is unlikely to be approved.

If a suitable substitute cannot be found for a match, the Tournament Director will award an adjusted score to the non-offending side in accordance with the E.B.U. White Book.

Requests for substitutes for what the I.C. considers to be convenience reasons will **not** be approved. Notwithstanding the foregoing, the T.D. is empowered to make emergency substitutions.

#### **Systems**

All players participating in this event must have submitted a copy of their system in electronic format to CBAI National Headquarters (info@cbai.ie) with their entry, so that their system may be uploaded to www.cbai.ie and is available to their opponents.

Both members of a partnership are restricted to a single system and both must play the same system and methods in bidding and play.

Players may have a copy of their own system to hand during the event but may not refer to it during play, unless playing online.

The W.B.F. Convention Card or equivalent must be used and may be downloaded at website below:http://www.ecatsbridge.com/documents/wbfinfo/systemsinfo/conventioncards.asp Hard copies of the W.B.F. Convention Card are available from the C.B.A.I. National Headquarters. Failure to fulfil this obligation or presentation of a Convention Card that, in the opinion of the Tournament Director, is insufficiently detailed, will render each pair liable to an automatic penalty.

Highly Unusual Methods (HUMs) are not permitted.

Brown Sticker Conventions (BSC) are permitted, subject to full disclosure. Up to three BSC may be used by a partnership, details of which must be submitted on the appropriate form (available from C.B.A.I. National Headquarters) when entering the respective trials. Failure to submit same in electronic format with the entry will result in these Methods and/or Conventions being prohibited.

### General

The International Committee is empowered to alter any of the arrangements or conditions including time and dates, and to decide on all matters affecting these trials.

The CBAI will follow any guidance in the EBU White Book in cases not covered by our own regulations.

Each player who enters these trials is agreeing to play in any national trials that they qualify for.
